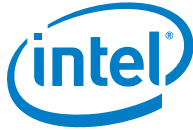

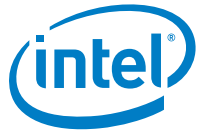

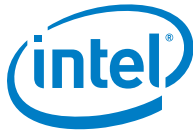


1 *Driver Information*

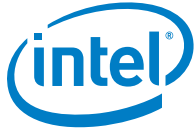

3 *Enabled Features*

- Supports GPIO multiplexing setting.
- Supports GPIO setting query – queries the multiplexing information of the GPIO pin.
- Supports GPIO direction setting – configures the selected GPIO pin as an I/O pin.
- Supports GPIO read pin – read pin's level value when the GPIO pin is configured as an input pin.
- Supports GPIO write pin – configures pin level to high or low when it is configured as an output pin.

- Execute the Intel Processor, Win7* IO Drivers 64Bit.msi to install the 64-bit driver.
- Execute the Intel Processor Win7* IO Drivers 32Bit.msi to install the 32-bit driver.
- Uninstall the driver from **Control Panel\All Control Panel Items\Programs and features** or by selecting **MSI installer** again.
